### MEASURING AND HEIGHT CARD INFORMATION

It is the exhibitor's responsibility to have their dog measured at any trial necessary. It is also the exhibitor's responsibility to mark their entry form correctly as to measuring status. Be sure to refer to Agility Rules and Regulations for full details

#### NEW Simplified Jump Height Card Process

- You no longer have to include a copy of your jump height card.
- You need to check the box "YES" on form if your dog will require measuring at this trial. Check "NO" if your dog will not need measured.

### DOGS ELIGIBLE TO ENTER

All dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate in this trial.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) must be spayed or neutered in order to compete. Wherever the word "dog" is used it includes both sexes.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to the AKC Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under **four** months of age are prohibited from the trial grounds.

### OBSTACLES AND RING CONDITIONS

Obstacles will meet the specifications for obstacles in the current edition of the AKC Regulations for Agility Trials. M.A.D. Agility's equipment is within all specs to AKC requirements. 24" spaced weaves, break-away tires and contacts rubberized. Ring sizes will be 100' x 100' for both rings.

### MEASURING OFFICIALS

No measuring official currently planned. If one becomes available it will be announced in final confirmation letters.

online, phone or verbal entries accepted. No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Illegible entries will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry and the Club will add a \$20.00 collection fee to the amount of each returned check.

No entry will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused or barred from competition by the action of the event committee.

**Refunds for Bitches in Season / injured dogs: A refund of entries minus a service fee of \$15.00 / dog/ day for bitches in season or injured dogs will be granted when a veterinarian's letter is presented as proof to the Trial Secretary prior to the start of the 1<sup>st</sup> trial day dog is entered. Must use official Veterinary's Letter Head.**

**Trial Secretary will not be held responsible for entries or changes not received at all or not received by any deadline.** It is the **exhibitor's responsibility to follow up on any correspondence with the Trial Secretary before any deadline date.** If you do not get an email reply back from the Trial Secretary it most likely means she did not get it and you need to try to contact again using an alternative form of communication.

### COURSE WALK-THROUGHS AND WARM-UP INFORMATION

Handlers will be able to walk each course prior to the start of each class. No dogs will be allowed on course during this time. Handlers with multiple dogs may request to walk with a different height other than the one they are entered in to help accommodate conflicts. It is the handlers responsibility to coordinate conflicts by consulting the judge and ring gate steward. Handlers are not permitted to move themselves on the gate sheets.

- Saturday Only** - ARC will be awarding top scoring Rottweilers with the following:
- 11" Armetale: Highest Scoring Rottweiler in Agility Trial (STD / JWW) and a **Pro Plan Garment Bag offered by Pro Plan**
  - 9" Armetale: Reserve Highest Scoring Rottweiler in Agility Trial (STD / JWW)
  - 7" Armetale: 1<sup>st</sup> Place Rottweiler in each class.

Additional Rottweiler awards may be available and must be signed up for prior to the start of the 1st class on Saturday. **Sign up at the ARC Booth to be eligible.**

Method of determining HIT, RHIT and HS Rottweiler awards:

- Regular and Preferred Rottweilers are eligible
- Qualifying runs, as defined by AKC Agility Regs are required
- Qualifying runs in either STD or JWW are eligible
  - Q runs in other classes (FAST/T2B) are not considered.
- All levels (Nov, Opn, Ex, Mas) are eligible
- HIT determined by the highest qualifying score **in either** STD **or** JWW, with scoring ties broken by highest Yards Per Second (YPS)

Method of determining High Scoring Jr. Handler Awards (handling Rottweilers Only)

- All levels, Regular and Preferred, are eligible
- Qualifying runs, as defined by AKC Agility Regs are required
- Qualifying runs in either STD or JWW are eligible
  - Q runs in other classes (FAST/T2B) are not considered.
- Ties in scores are broken by higher level of competition, with further ties within that level decided by YPS (that is the faster dog)

## ADDITIONAL EXHIBITOR INFORMATION

- 1. NO ALCOHOLIC BEVERAGES PERMITTED ON SHOW GROUNDS.**
- 2. All dogs must be on leash when not competing in the ring or at the practice jump.**
- No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.
- Exhibitors, through submission of entry, acknowledge that they are familiar with AKC agility rules and regulations and that their dogs are familiar with and able to perform all obstacles safely.
- Telegraph, telephone, email, AKC online entries, fax, and unsigned entries will not be accepted.
- All calls to the Trial Secretary must be before 2 PM Mon – Fri or 9am-9pm Sat / Sun.
- Entries not on official AKC entry forms or photocopies of entry forms without agreement and rules printed on the reverse side of the Official AKC Entry Form are NOT acceptable and will be returned!
- Postdated checks and returned checks do not constitute a valid entry fee. The club treasurer will add a collection fee of \$20.00 to the amount of each returned check.
- Owners are responsible for errors in making out entry forms. Entry fees do not have to be refunded in event of such error.
- Exhibitors are responsible for cleaning up after their dogs at the show site. Failure to do so will result in dismissal.
- Dogs may arrive any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.
- Judges will not wait for any dog holding up the judging schedule. Owners or agents alone are responsible for the presence of their dogs in the agility ring when they are called to be judged.
- It is expressly understood that every dog and child at this trial are in the care, custody and control of its owner, handler, or parent during the entire time the dog or child is on the trial premises. Any exhibitor whose dog and/or child create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior, may, at the discretion of the Trial Committee, be asked to leave the show site. In such case, no refund of any fees will be made.
- Neither the club nor IN THE NET are responsible for the loss of, damage to, or death / injury of any person or dog exhibitor on the grounds, or the possessions of any participant, whether the result of accident or any other cause.

INSTRUCTIONS

Handlers may opt to enter in a higher height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine PartnersSM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767.
