3 Licensed trials offered, Instinct offered once each day, Novice, Open, Senior and Master

Class Descriptions:

RATI (Rat **I**nstinct Class): Three PVC tubes placed in plain sight on the course. Tubes will be: one dry, one with litter only (no rat), and one with both litter and a rat. Time Limit: 1 minute.

RATN (**N**ovice Barn Hunt): Three PVC tubes hidden on the course. Tubes will be: one dry, one with litter only, and one with both litter and a rat. Time Limit: 2 minutes.

RATO (**O**pen Barn Hunt): Five PVC tubes hidden on the course. Tubes will be: one dry, two with litter only, two with rats and litter. Time Limit: 2 minutes,30 seconds

Dogs may enter both the Instinct Test and Novice class in the trial. All entries must be accompanied by entry fees to be valid. A returned check does not constitute a valid entry. There will be a \$50 fee for all returned checks. No entries will be taken over the phone or electronically. **Make check payable to CRC.** Send entries & fees to the trial secretary. Dogs **must** have a Barn Hunt registration number to enter

Entries open Feb 22 and close Apr 29, pre entries are \$15.00 for Instinct Test and \$20.00 for Novice and Open, \$25 Senior and Master. Limit 100 runs per day.. Late entries and day of entries may be accepted if space allows. Late entry fees are an additional \$5.00 per run.

EXHIBITOR INFORMATION --

This event will be held outdoors – rain or shine! Please dress appropriately! Please note this event is being held in conjunction with CRC's annual ATTS and CGC testing. Please be attentive to your dog and be respectful to those around you. Restrooms are available in the Expo Center; food will not be available on site, but there are numerous fast food restaurants within a few minutes' drive.

All dogs must be on lead and under control while on the trial grounds. **FLEXI LEASHES ARE NOT PERMITTED. Dogs MUST run naked, no collar or harness.** Please pick up after your dog and dispose of waste in designated areas.

Dogs will be run in height order with dogs being handled by the same person separated into different staged groups. No more than 100 runs per day will be accepted.

Bitches in season are eligible for entry but will be required to be kept separate from all other dogs, must wear panties and will be run at the end of their class/trial. If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing.
