#### Non-Regular Classes (Involving Single Dog Entries) VETERAN DOG VETERAN BITCH

7 years & under 9 years; 9 years & under 11 years; 11 years & under 13 years; 13 years and over A Class for Dogs and a class for bitches seven years of age and older.

Dog/Bitches entered in Veteran Class need not be intact. Spayed and Neutered animals are eligible. Winners of the above classes, if otherwise undefeated, are eligible to compete for Best of Breed.

#### WORKING DOG WORKING BITCHES

A Class for Dogs and a class for Bitches with working/performance titles. The Dog/Bitch must have earned one or more of the following AKC titles: CD, RN, TD, HS, NA, NAJ, NAP, NJP, NF, NFP or an American Rottweiler Club CS. Spayed and Neutered animals are ineligible to be entered in this class. Champions of Record are eligible to enter. Winners of these classes, if otherwise undefeated, are eligible to compete for Best of Breed.

**BEST OF BREED COMPETITION:** The following categories of dogs may be entered and shown in Best of Breed Competition. Dogs that are Champions of Record and dogs that according to their owners records have completed the reqirements for a Championship but whose Championships are unconfirmed. The showing of dogs whose Championships are unconfired is limited to a period of 90 days from the date of the show where a dog completed the requirements for a Championship according to the Owner's Records.

CRC JUDGE'S AWARDS OF MERIT

#### Non-Regular Classes (Involving Multiple Dog Entires)

- Stud Dog Class For Stud Dog and two of their Get. Stud Dog must be entered in the Stud Dog Class and must be shown in the ring with their Get. The Owner of the Stud Dog need not necessarily be the owner of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC Policy, or the standard for its breed. Get must be entered in a regular class, Best of Breed Competition or some other non-regular class.
- **Brood Bitch Class -** For Brood Bitch and two of their Produce. Brood Bitch must be entered in the Brood Bitch Class and must be shown in the ring with their Produce. The Owner of the Brood Bitch need not necessarily be the owner of the Produce. While the merits of the Brood Bitch are not to be considered in the placement of the entry, the Brood Bitch must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC Policy, or the standard for its breed. Get must be entered in a regular class, Best of Breed Competition or some other non-regular class.

NOTE: As the judge's decision in the Stud Dog or Brood Bitch Class is based on the merits of more than one dog/bitch, no one of the dogs/bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won this class.

\*Chapter 11, Section 8: of the "Rules Applying to Dog Shows: providing that a "castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class".

## BEGINNER PUPPY SPECIAL ATTRACTION (4-6 MONTH OF AGE) AKC Sanctioned Beginner Puppy Competition - Judge: Bradford Dunn

The American Kennel Club has designed the Beginner Puppy Special Attraction to be an opportunity for puppies to interact with people and other dogs under a puppy friendly judge and show ring. New pure-bred puppy owners are encouraged to enter to explore competing in AKC Events. One combined class, not divided by sex, will be offered for Rottweilers that are four months and under six months on Wednesday, May 10, 2017. An AKC registration number or litter number will be required.

Dogs are required to be vaccinated (including rabies) in accordance with their veterinarian's protocol.

AKC Rules Applying to Dog Dealing with Misconduct will be applicable to any person and dog entered at this competition. All applicable rules found in Rules Applying to Dog Shows will govern the conduct of this competition unless these regulations state otherwise.

Exhibitors should plan on opening the mouth of their puppy for the judges. Breed standard disqualifications such as color, height, weight or dentition shall not be a point of consideration in the judging process for this 4-6 month Puppy Special Attraction event.

Professional Handlers are not allowed to exhibit in this competition. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards or otherwise advertised or represented themselves as handling dogs for pay.
