In The Net (indoor soccer field) is located just off RT 117 (Forge Rd). Turn onto Airport Road at the intersection at REIGLE'S AIRPORT and it is located on your RIGHT less than a mile away from REIGLE'S AIRPORT.

Please consult the AKC Regulations for Agility Trials for a complete description and eligibility for entry into these classes. The exhibitor is fully responsible for entering the dog in the correct class(es)/height division. Dogs running in a lower height division than they are eligible for will be eliminated.

MEASURING AND HEIGHT CARD INFORMATION

It is the exhibitor's responsibility to have their dog measured at any trial necessary. It is also the exhibitor's responsibility to mark their entry form correctly as to measuring status. Be sure to refer to Agility Rules and Regulations for full details

NEW Simplified Jump Height Card Process

- You no longer have to include a copy of your jump height card.
- You need to check the box "YES" on form if your dog will require measuring at this trial. Check "NO" if your dog will not need measured.

DOGS ELIGIBLE TO ENTER

All dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate in this trial.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) must be spayed or neutered in order to compete. Wherever the word "dog" is used it includes both sexes.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under **four** months of age are prohibited from the trial grounds.

OBSTACLES AND RING CONDITIONS

Obstacles will meet the specifications for obstacles in the current edition of the AKC Regulations for Agility Trials. M.A.D. Agility's equipment is within all specs to AKC requirements. 24" spaced weaves, break-away tires and contacts rubberized. Both rings on Sports Turf surface using fully enclosed baby gates as ring boundaries.

MEASURING OFFICIALS

Neither judge is a VMO. At this time official measuring is not available at this trial. If a VMO or Rep is known to be attending by closing, we will announce it in the final confirmation letters.

ENTRY FEES & INSTRUCTIONS

If you want to know when your entry is delivered, please use one of the options offered by the USPS for delivery confirmation. Preliminary confirmations will be sent as entries are processed. <u>Make checks Payable to: CRC.</u> Express Mail must not require signatures. No email, phone or verbal entries accepted. No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Illegible entries will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry and the Club will add a \$30.00 collection fee to the amount of each returned check.

No entry will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused or barred from competition by the action of the event committee.

<u>Bitches in season</u> will be awarded a refund, **less \$6.00/run** processing fee. Notification in writing (including a veterinarian's certificate) must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial. Notifications in writing can be emailed to the TS if not attending the trial but must still be received 30 minutes prior to the start of the first class.

<u>Injured dogs</u> will be awarded a refund **less \$8.00/run** processing fee with a veterinary / physician's certificate. Physician's Certificate should be mailed or emailed to the trial secretary prior to trial, or personally presented to trial secretary prior to the commencing of judging.

Trial Secretary will not be held responsible for entries or changes not received at all or not received by any deadline. It is the <u>exhibitor's responsibility to follow up on any correspondence with the Trial Secretary before any deadline date</u>. If you do not get an email reply back from the Trial Secretary it most likely means she did not get it and you need to try to contact again using an alternative form of communication.

COURSE WALK-THROUGHS AND WARM-UP INFORMATION

Handlers will be able to walk each course prior to the start of each class. No dogs will be allowed on course during this time. Handlers with multiple dogs may request to walk with a different height other than the one they are entered in to help accommodate conflicts. It is the handler's responsibility to coordinate conflicts by consulting the judge and ring gate steward. Handlers are not permitted to move themselves on the gate sheets.

Reminder for Mixed Class entries:

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

Entering For Exhibition Only (FEO)

- For Exhibition Only may be offered at the option of the host club. FEO will allow exhibitors to work with their dogs in a trial environment. FEO is only allowed in the Time 2 Beat and FAST classes Participation in FEO is non-qualifying.
- FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out to the scribe and the judge.

Fix and Go On (FNG)

Fix and Go On is not pre-entered; rather, it occurs during the course of the

FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score.

WORKERS

White boards for worker sign ups will be available at the trial. We thank everyone who appreciates and respects the work involved with putting on an efficiently run trial and works at least one class a day to help!

COVID

- 1. NO Alcoholic Beverages permitted on show grounds during show hours.
- All dogs must <u>be on leash</u> when not competing in the ring or at the practice iump.
- 3. No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.
- Exhibitors, through submission of entry, acknowledge that they are familiar with AKC agility rules and regulations and that their dogs are familiar with and able to perform all obstacles safely.
- Telegraph, telephone, email, AKC online entries, fax, and unsigned entries will not be accepted.
- 6. All calls to the Trial Secretary must be before 1 PM Mon Fri or 9am-9pm Sat / Sun.
- Entries not on official AKC entry forms or photocopies of entry forms without agreement and rules printed on the reverse side of the Official AKC Entry Form are NOT acceptable and will be returned!
- 8. Postdated checks and returned checks do not constitute a valid entry fee. The club will add a collection fee of \$30.00 to the amount of each returned check.
- 9. Owners are responsible for errors in making out entry forms. Entry fees do not have to be refunded in event of such error.
- Exhibitors are responsible for cleaning up after their dogs at the show site. Failure to do so will result in dismissal.
- Dogs may arrive any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.
