Colonial Rottweiler Club will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. CRC reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against CRC or any official thereof.

Please make accommodations for outdoor crating and bring shade and water for you and your dog. Appropriate action will be taken if dogs are found in hot car. Colonial Rottweiler Club, its members, and representatives will NOT be liable for damages.

By providing an email address on the entry form, you agree to electronic correspondence for confirmation and times of testing

Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by the Judge, or barred from competition by the action of the Test Committee. If because of riots, civil disturbances, or other acts beyond the control of the CLUB it is impossible to open or complete the show, no refund of the entry fee will be made.

It is the responsibility of the person submitting the entry form to ensure accuracy of the data on the entry form. In the event of errors or cancellation, no refund will be given after the published closing date.
