### Farm Dog Certification May 4, 2025

Entry fee: \$35.00 per dog per test; checks payable to Ice-Bern Farm LLC.

#### NO REFUNDS WILL BE GIVEN

Registration will open on February 15th at 12:00 pm. Day of entries will be accepted starting at 8:00 AM until 10:00 AM or when limit is reached, whichever comes first. Entries will be accepted in the order they are received.

Testing will start at 9:00 AM for all trials. Trials will run concurrently with 2 trial. To Title Your Dog: You must pass two Farm Dog Certified Tests, under two different judges to receive your AKC FDC title. This is a non-competitive event. You do not have to pre-qualify.

There will be a judge's briefing before each test. NO DOGS at briefing please.

## Conditions of Entry

Incomplete entries or forms without signature will not be accepted. Farm Dog Certified Tests are open to all dogs at least 9 months of age that are individually registered with AKC, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration, or dogs enrolled in the AKC Canine Partners program. Dogs with breed disqualifications and monorchid/cryptorchid dogs are eligible to participate.

Ice-Bern Farm LLC will be following Federal, State, Local, and AKC suggested guidelines to keep workers and FDC test participants safe. AKC Covid- 19 recommendations can be found here: https://www.akc.org/press-center/covid-19-updates-from- the-american-kennel-club/

#### Please read:

The FDC Test is non-competitive. Dogs must be on a leash at all times while on testing site unless confined in a crate, kennel or vehicle. The leash shall be four to six feet in length. Dogs must wear a secure, well fitting, flat collar during the test evaluation. Handlers can use verbal cues, hand signals, and praise provided if it is not excessive in the opinion of the judge

Entered dogs will not be permitted into the testing area until their testing time. There will be crating area for the dogs. There will be a holding area for the next 3 exhibitors. Only the dog and handler may be in this area. All other participants must wait at least 20 feet from the test area.

There is plenty room for spectators.

\*\*This is a TRUE working farm. Thoroughbred Race Horses. DO NOT ENTER any of the BARNS or walk freely around the upper property. We are fortune to have access to this beautiful farm. Please pick up after dog. Do not let the boys pee all over the fence posts etc. Sad I even have to say this, but well ...I do. Parking will be right as you enter then gate. There is a porta pot available. There is also a pool in the building that we are will have a secretary station in. The POOL IS OFF LIMITS without permission and a scheduled time. There is no life guard on duty. The pool is 17 feet deep. Please avoid the area. Thank you!

You may bring pop up tents...picnics etc. There is plenty of room. Come and have a good time with your dog. Remember there is not such thing as a bad day with your dog!

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim of loss, injury or damage to this dog.
